Participation trophies will be awarded to Division 1 (Ages 3-4), Division 2 (Ages 5-6), Division 3 (Ages 7-9) and Division 4 (Ages 10-12). Contestants are required to wear western attire (hat, boots, jeans, belt, etc...) at all events. The purpose is to have fun, learn and promote the sport of rodeo and its sponsors. Contestants are judged on personality, appearance and poise. Contestants are not required to reside in Morgan County or the State of Alabama. *Queen contestants may not wear the crown or banner of another title to Morgan County Sheriff's Rodeo events while competing in the Morgan County Sheriff's Rodeo Queen Pageant unless they are invited to a rodeo/pageant event as visiting royalty by the Pageant Committee.*

The winner of each division may not compete in the same division the following year.
